3. Reports from recent meetings

3.1 ICC meetings (TGD)

• FCSSMG meeting at Edinburgh:

- 1 Oct. 2001 deadline for delivery of FCSS version 0.1 changed to 1 Apr. 2002 with preliminary versions to be delivered beforehand.
- Next meeting 10 November at MPE.

• ORAC DR demonstration:

• This went well, but no feedback yet from Otto or Pjotr. ORAC is written in PERL - would need to be converted to JAVA.

• ICC Definition Team meeting at Edinburgh:

- JPYTHON could replace IDL
 - Discussion: BMS is not keen on eliminating IDL at this stage.
- The meeting discussed the ATC programme for ICC development.

 Discussion: ATC participation needs to be clarified. Their specific expertise is OOP and conversion of use-cases into S/W design, so their limited effort should be focussed on this.
- Ambiguity over percentage effort from Giovanni Bisaglia is it 100% or 30%.
- Next IDT meeting planned for early December

- Agreement between IFSI and CEA on interfaces is close. Christophe Cara is producing new interface document for which BMS/JD are to provide some relevant information
- Requirements on WE from individual subsystems were discussed and actions defined:

Detectors - next week

MCU - being revised

Calibrators and BSM - are still outstanding

3.3 EMC Videocon (19 Oct.)

- New suggested grounding scheme proposed by John Delderfield, who has an action to document it. The plan is to approve it at next week's meeting in Pasadena. FTS and photometer will be separate. Grounding can be at warm end or via 2-K strap at the cold end. Need to have ability to isolate at 2-K strap.
- RF filters were discussed. They should be included explicitly in the final grounding scheme

8. Instrument schedule and Development Plan

- Critical items are the Structure, Detectors and Mechanisms (largely driven by BSM)
- A detailed Structure development plan exists and nature of problem is well understood
- This is not necessarily true of the Detectors and BSM
 - Detectors: should be clarified at or shortly after Nov. 9/10 meeting
 - BSM: A progress review should be held before the end of the year. The decision on commercial mechanism or in-house option needed soon (depends on whether LAM can do warm electronics)
