1 Introduction

In the time of the "paperless world" most of the documentation in the Herschel project is distributed in electronic format. In order to streamline the documentation transfer and simultaneously circumvent some E-mail server boundaries w.r.t. file size – at least at Astrium – we have set up the FTP server as a platform for submission and transfer of documents. At the same time the system will allow the controlled receipt and distribution of documents not only at Astrium.

2 Server Configuration

The server is configured such that all major companies having direct contact with Astrium have their own folder set up. Every company has been provided – or will be provided - with the detailed address and password for access to their folder. At present folders have been set up for the final customer ESA, the customer and Prime Contractor Alcatel, the core team company Alenia, for the three instruments HIFI, PACS and SPIRE, and in addition a "Common" for general purpose use.

In case a participating company in the Herschel EPLM project does not have his own FTP server a dedicated folder for that company will be installed on the Astrium FTP server with two subfolders called "to Company X" and "to Astrium".

The allocated size on the Astrium FTP server is limited and consequently it is not intended to serve as a documentation system or its back-up. It is a platform providing the possibility of file and documentation transfer. The recipient is requested to delete the entry after having copied it onto his system and successfully verified the correct receipt.

3 Distribution of Documents / Files

3.1 Distribution of documents/files by Astrium

All documents officially submitted, be it for approval, review, commenting or archiving, will be placed onto the Astrium FTP server into the respective folders. At the same time a despatch note as fax will be submitted to the addressees providing the document details (e.g. document title and number with required action) and the exact location (folder and subfolder) on the Astrium FTP server. These actions are performed by the documentation responsible at Astrium. The recipient is requested to copy the document into his system, verify correct receipt, include it in his documentation system and thereafter delete the entry on the FTP server. At the same time the recipient shall return the signed despatch note by fax to Astrium. In this way Astrium can verify that the document has been received by the addressee.

3.2 Distribution of documents/files to Astrium

All documents officially submitted, be it for approval, review, commenting or archiving shall be placed by the sender into the respective folder on his own FTP server. At the same time the sender shall submit a despatch note as fax to the Astrium single point of contact for documentation stating the exact location (folder and subfolder), which document he has placed there and what action is required from Astrium. The Astrium documentation responsible will copy the document into our documentation system and initiate the appropriate action. Thereafter the document will be deleted from the FTP server such that the sender has a positive indication that his submittal has been received. In addition the signed despatch note will be returned by fax.

3.3 Using the COMMON Folder

In order to ease the dissemination of large files circumventing the file size boundaries of Email submissions this folder has been set up. Files and documents placed in this folder should in principle follow the same rules as described above for distribution of documents/files to and from Astrium. The only difference is that these submissions are to be considered as direct information exchange between two persons and in consequence thereof will not be included in the Herschel documentation system at Astrium. In order to avoid overflow this folder will be adjusted such that all information older then 10 days will be automatically deleted.


4 NOTE - Official submission of documents

The dissemination of files using the FTP server will be the **only** way of **officially** submitting electronic information to and from Astrium. All E-mail submission of files and documents will be considered as "**for information only**".




